

SECTION 00 10 00 INVITATION TO BID

Sealed Proposals for the construction of “1st Street, Bridge, and Instream Improvements for the City of Norfolk,” JEO Project No. 181486.01, QuestCDN No. 8092261, will be received by the City Clerk at 309 N 5th Street, Norfolk, NE 68701, until 10:30 a.m. on the 24th day of February 2022, and thereafter will be read aloud.

The work is generally described as follows: Improvements include approximately 11,500 SY of removals and 9,000 SY of pavement including an intersection conversion into a roundabout. 600 linear feet of 48” RCP storm sewer and 10 storm inlets with associated laterals. 60’-0” long IT girder bridge and 225 linear feet of modular block retaining wall. 19 street lighting fixtures with associated conduit. 1800 LF of Instream Improvements to the North Fork River, 0.73 Acres of Wetland mitigation, 4,500 CY of embankment and 8 instream boulder/rock grade structures. Temporary and permanent traffic control, extensive grading, and water mains are also appurtenances of the project.

Proposals will be taken for said construction work listed above by unit prices, as an aggregate bid for the entire project.

All Proposals for said construction work must be made on blanks furnished by the Engineer and must be accompanied by Bid Security of not less than 5% of the amount bid. Bid Security to be made payable to the Treasurer of the City of Norfolk as liquidated damages in case the bid is accepted and the bidder neglects or refuses, to enter into contract and furnish bond in accordance herewith.
