at which hour, or as soon as possible thereafter, the bids will be opened, read aloud, and tabulated, in the presence of all attending bidders to furnish said labor, materials, and equipment broken down to accurately reflect unit prices for all estimated quantities.

This project consists of concrete repairs and an alternate bid for reconstruction of Raasch Avenue from 34th Street to 400' east, 34th Street from Raasch Drive to Highway 275, 25th Street from Highway 275 to 550' south. The repairs or reconstruction will include removal and replacement of concrete pavement, updating handicap ramps, adjust drop inlet to grad, erosion control and traffic control. Both panel replacement and full replacement of concrete street sections will be considered in the bid. Entire project consists of approximately 1926 square yards of concrete repair if full replacement bids are selected.

All work called for in the plans and specifications shall be furnished in strict accordance with the plans and specifications prepared by the Engineering Division of the Public Works Department of the City of Norfolk, and bids will be received only upon the forms furnished by the City.

Each bid must be accompanied by a bid bond or certified check on a bank whose deposits are insured by the Federal Deposit Insurance Corporation in the amount of 5% of the total bid price and must be payable without condition to the Treasurer, City of Norfolk, Nebraska, as evidence of good faith of the bidder and as agreed liquidated damages in case the bidder whose proposal is accepted by the City of Norfolk fails to enter into contract within ten (10) days from the Notice of the Award or fails to furnish acceptable bond to complete the work and pay for all labor and materials used, said bond to be in the amount of 100% of the total bid price.

The bid security (i.e. bid bond or certified check) as outlined in Articles I and III of these specifications shall be submitted in a **separate envelope** along with the proposal. The bid security shall be clearly marked and accessible without needing to open the envelope containing the proposal. Any proposal that does not have bid security as outlined above will not be accepted and is subject to rejection.
