

## Notice to Contractors

Sealed bids will be received in the City offices, 309 North 5<sup>th</sup> Street, Norfolk, Nebraska, until 2:30 p.m. on the 10<sup>th</sup> day of May, 2022 to furnish all labor, materials, use of contractor's equipment, plant, and all else necessary to properly construct all of the improvements for the East Benjamin Avenue Connector Trail, RTP-2019-003 Project:

The project consists of the construction of the following trails:

1. A 10 ft. wide trail approximately 1,224 linear feet along the west side of Victory Road from Sycamore Avenue to Benjamin Avenue.
2. A 10 ft. wide trail approximately 476 linear feet along the north side of Benjamin Avenue from 476 feet west of Victory Road to Victory Road.
3. A 10 ft. wide trail approximately 5,233 linear feet along the north side of Benjamin Avenue from Victory Road to the tie-in with the existing trail on the east side of Nebraska State Hwy. 35.

The work includes construction of the trails described above, construction of pedestrian signalization at Hwy. 35, extension of existing storm sewers, and other work appurtenant to construction of the project.

At said hour, or as soon as possible thereafter, the bids will be opened, read aloud, and tabulated, in the presence of all attending bidders to furnish said labor, materials, and equipment broken down to accurately reflect unit prices for all estimated quantities. All work called for in the plans and specifications shall be furnished in strict accordance with the plans and specifications approved by the Engineering Division of the Public Works Department of the City of Norfolk, and bids will be received only upon the forms furnished by the City.

Each bid must be accompanied by a bid bond or certified check on a bank whose deposits are insured by the Federal Deposit Insurance Corporation in the amount of 5% of the total bid price and must be payable without condition to the Treasurer, City of Norfolk, Nebraska, as evidence of good faith of the bidder and as agreed liquidated damages in case the bidder whose proposal is accepted by the City of Norfolk fails to enter into contract within ten (10) days from the Notice of the Award or fails to furnish acceptable bond to complete the work and pay for all labor and materials used, said bond to be in the amount of 100% of the total bid price.

The bid security (i.e. bid bond or certified check) as outlined in Articles I and III of these specifications shall be submitted in a **separate envelope** along with the proposal. The bid security shall be clearly marked and accessible without needing to open the envelope containing the proposal. Any proposal that does not have bid security as outlined above will not be accepted and is subject to rejection.
