#### **PUBLIC HEARINGS**

Public hearing at the request of Eric Taake for SBET, LLC for a zoning change from A (Agricultural District) to C-3 (Service Commercial District) at 802 S. 25th Street. Chair Snodgrass opened the hearing at 7:33 and asked for anyone in the audience to speak.

Todd Borgemyer said that the address, 802 S. 25th Street, is actually the address to property he owns. He asked if that was used as a reference. It was noted that that specific address will be removed and it is in error. He has no problem with the zone change or development.

Eric Taake, proposed developer, said they want to develop the area into a fitness center and business park. The fitness center is proposed for the northwest corner of the property.

Greg Lambrecht, owner of abutting property, questioned an existing access and if it will continue to be there. Trent Howard advised that a Master Plan will be completed that will show access, grading and drainage.

There was no other discussion and Chair Snodgrass closed the hearing at 7:37 a.m.

#### Oban Cyhawk Addition-Final Plat
