PUBLIC HEARING (1)

Public hearing at the request of LeRoy J and Louise Torkelson for a zone change from R-1 to O-D at 1201 N. 13th Street.

Chair Snodgrass opened the hearing at 7:31 a.m. and asked for anyone in favor of the zone change to speak.

LeRoy and Louise Torkelson, owners of the property, said they want to sell the building. The building has been a veterinarian's office since 1954 and has been zoned R-1. In order to sell it, they need to rezone it to O-D (Office District). Steve Kimes, the buyer, said he wants to relocate his financial planning office to this building. He plans to have to planners in the office as well as support staff. The building will be rezoned to hold these offices as well as a waiting area and support areas.
